Cosplay Contest Rules

River Region Comic Con Cosplay Contest 2018
NACC Contest Entry Form and Rules

- This is an open genre costume contest, meaning there are no restrictions regarding the source material of a competing cosplay.
 - All entries are strongly encouraged to bring reference material for their costume(s). While we will not turn away entries that do not bring reference material, it is very helpful! Not all judges know all characters, so reference material is in everyone's best interest
 - Cosplays can be store-bought, commissioned, or made by the contestant.
 - One costume entry per person.
 - A parent or guardian must accompany all contestants in the Youth and Kids categories for both the pre-judging and the Cosplay Contest presentation.
 - Contestants may not enter a costume that has won an award from any other convention. If you have a question about exceptions to this rule, please contact us.
 - All costumes must abide by the rules of the River Region Comic Con Cosplay Policy and Weapons Policy. If a policy violation is discovered by any of the convention staff or judges panel, that entry will be disqualified.
 - All contestants MUST fill out and submit an entry form. A valid convention badge will be required.
 - Special stage requests will be considered but cannot be guaranteed. Requests should be submitted in writing along with the entry form.
 - No contest entries will be accepted once pre-judging has begun at 2:30pm.
 - Contestants who do not appear in full costume at pre-judging will be disqualified from the contest.
- The following winners will be selected to receive awards:
 - A single winner will be selected for the Adult Male, Adult Female, Youth and Kids categories
 - All decisions made by the judges are final. All prizes will be awarded at the conclusion of the contest.
 - Any prize not claimed by the conclusion of River Region Comic Con (March 17, 2018 at 6pm) will be forfeited.
 - Any item or activity that presents the possibility of damage to the entrants, their costumes, the audience, or the facility is prohibited.
 - Any participant may be disqualified from the contest by River Region Comic Con Staff for failure to observe any of these rules.
