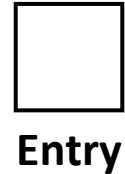

EXHIBITION: I just want to walk the stage! This category skips prejudging and is not considered for prizes. Purchased costumes may participate in this category and any age can be in this category.

***NO STORE BOUGHT COSTUMES WITHOUT ANY MODIFICATIONS MAY BE ENTERED IN THE BELOW CATEGORIES:**

ADULT (Ages 16 & Up): I have made/modified **at least 50%** of my costume (see rules) and want my craftsmanship to be judged.

*YOUTH (8-15 years old)

*CHILD (7 and Younger)

PARTICIPANTS MUST READ AND AGREE TO ALL RULES ON THE BACK OF THIS FORM.

PREJUDGING TIMES: You will be assigned a time slot at pre-registration during which you will be prejudged. Please show up **AT THE START OF THE SLOT** to assure that we can judge everyone in a timely manner to reduce wait times.

THE COSPLAY CONTEST WILL BEGIN AT 5pm IN the Lower Level L1 Front Room (downstairs Panel Room). All contestants should report to **the Lower Level L1 Front Room (downstairs Panel Room)** to be lined up in their categories by organizers by **4:50pm**.

I agree that I have read and will comply with the rules of the River Region Comic Con Cosplay Contest in partnership with North Alabama Cosplayers Club (NACC), and I further consent to the use of my picture, video footage, and the likeness of my cosplay by River Region Comic Con & NACC in future promotional efforts.

I understand that I **MUST** report to the **Lower Level L1 Front Room (downstairs Panel Room)** during my pre-judging time slot to complete the entry process; if I do not, I will be disqualified.

NACC Contest Entry Form and Rules

- This is an open genre costume contest, meaning that there are no restrictions regarding the source material of a cosplay as long as it conforms to all other rules.
- Costumes must be family friendly (PG-13).
- Lifestyle clothing is not considered a costume for this contest.
- No costume (oneself) is not a costume.
- One costume entry per person.
- All entries are strongly encouraged to bring reference material. Not all judges may be familiar with your character.
- Cosplays for any age contestant being entered in the EXHIBITION can be store-bought, commissioned, or made.
- **Cosplays being entered in the ADULT category must meet ALL of the following requirements:**
 - Made/modified by the entrant.
 - Modifications will be assessed by our judges and must be at least 50% modified from the original piece.
 - Commissioned costumes may only be entered if the creator is present.
 - **Store-bought costumes not allowed.**
 - The following items are allowed to be purchased: wigs, belts, shoes, jewelry, accessories, and props. Other items may be allowed at the judges' discretion.
- **Cosplays being entered in the YOUTH OR CHILD category follow the same rules as the ADULT category above with the exception that a parent or other relative/person may provide help to children in their costume construction and that store bought costumes may be considered for prizes if no craftsmanship entries are received.**
- A parent/guardian must accompany all contestants in the YOUTH and CHILD categories (15 and under) for both the pre-judging and the contest presentation.
- Contestants may not enter a costume that has won a major award from any other convention. If you have a question about exceptions to this rules, please contact us.
- All costumes must abide by the rules of the River Region Comic Con Cosplay Policy and Weapons Policy. If a policy violation is discovered, that entry will be disqualified.
- All contestants MUST submit an entry form. A valid convention badge is required.
- Special stage requests will be considered but cannot be guaranteed. Requests should be submitted in writing with entry form.
- **All contest entries after 2:30pm will be placed in the EXHIBITION category.**
- Judging time slots are assigned on a first come, first served basis.
- Contestants must appear in full costume at pre-judging or be disqualified.
- The following winners will be selected:
 - A 1st place will be awarded for the CHILD and YOUTH categories.
 - A 1st and 2nd place winner will be awarded for the ADULT category.
 - A Judge's Choice award will be given out by each judge.
- All decisions made by the judges are final. All prizes will be awarded at the end of the contest.
- **Any prize not claimed by the conclusion of the convention will be forfeited.**
- Failure to obey the rules of this contest or the convention overall will result in the contestant's removal from participation at the discretion of NACC leadership and/or convention staff.
